**Once an exemption has been given up, you cannot reclaim that exemption based on the same qualification.**

Students eligible for exemption from all or part of the Fundamentals level gained more than five years previously (at the date of initial registration as an ACCA student) should cancel these exemptions and complete the Fundamentals level exams should they wish to subsequently apply for a UK ACCA practising certificate and audit qualification.
