

Case n.2: Internship and Master Thesis

To obtain Polimi University Degree it is mandatory to prepare a Thesis that can be discussed through skype call

To obtain ESSCA Master in Management Grande Ecole Program, it is mandatory : → to attend a 6 months internship @ ESSCA Incubator

- > to prepare a Mater Thesis for another six months
- Thesis debate should be held in France

Admission (both for case n.1 or case n.2)

Recruitment process:

- Chinese universities will select and recommend Chinese candidates to MIP
- Student should submit the application to MIP (the stream must be determined when submitting the application).
- MIP and the EU Partner(where the candidate will attend the 2nd term) will evaluate together the application.

Interview from MIP

- Notice of acceptance and contract from MIP
- Mr. Li Xining on behalf of MIP assists the visa application

Admission (both for case n.1 or case n.2)

Requirements: applicants should be recommended by Chinese Universities and must reach the standard set by ACE partner Universities

ADMISSION REQUIREMENTS:

- 1. Application form
- 2. Curriculum vitae of educational and professional path;
- 3. Copy of bachelor degree in original language
- 4. University Transcripts listing all exams completed in original language
- 5. English certificate: IELTS 6.5;TOEFL iBT 89;Cambridge certification B; Pearson PTE 62; CETS new standardized 480
- 6. Copy of Passport
